CROMERR

CROss Media Electronic Reporting Rule

40 CFR 3

The CROMERR provides the legal framework for electronic reporting under all of EPAs environmental regulations.

To receive electronic reports, a program must utilize CROMERR-approved software and request approval from EPA to insure they have the legal authority to receive electronic reports.

COB CROMERR Timeline

- 2018 Purchased LinkoExchange (LE) and upgraded cloud-hosted Compliance-Tracking Software (CTS)
 - Linko staff began updating and converting existing data for transfer to cloud-based CTS and preparing tables for LE.
- 2018 EPA HQ Approval
- 2019 2021 COB-IPT Staff Changes / COVID
- 12/2021 Training SIUs in using LE and they began double-reporting (submitting paper copies and using LE)
- 2022 2023 Updated Ordinance
 - Major delays caused by more staff changes, multiple board approvals, attorney negotiations,
 City Council, etc.
- 03/2023 EPA Region 8 Approval of Major Modification
- 04/01/2023 Began Receiving Electronic Reports without paper copies submitted Began revising permits and enforcing E-Reporting.

Reasons for the Major Delays in Project

- One of first municipalities to seek approval but not first to get approval nationally. 1st in Colorado.
- COVID
- EPA-HQ easy
- EPA Region 8
 - Update Sewer Use Ordinance
 - Advice from municipality with approval.
- COB Staff Changes in Pretreatment & Attorney Office
- Ordinance hadn't been updated in many years, so we "edited" almost every section.
 - Added Definitions, CROMERR-related language, FOG, and corrected sections.
- Public Participation
 - Meetings with Stakeholders
 - Planning Board, Water Resources Advisory Board, and City Council



SIU Reporting

No SIU shall fail to transmit reports by electronic means by a designated electronic document receiving system that satisfies the requirements of CROMERR set forth in 40 CFR 3, including but not limited to the electronic signature agreement requirement, and verified with a valid electronic signature to develop a copy of record.

- Submit up to the deadline.
- Submit anywhere.
- Automatic Confirmation
- Less Paper
- Easier to Submit More Data
- Easy for backup person to submit.

- Must work with contract lab to get Electronic Data Deliverable in correct format or fix for upload.
- Some IUs are technically challenged.
- SIUs lock themselves out of account by not remembering password
 - Must wait on IPT staff to unlock them.
- Not conducive for FOG or Dental use fax.

Compliance Challenges

Laboratory Information System (LIMS)

- Our in-house Wastewater Environmental Laboratory changed LIMS during this change.
- Import from LIMS to CTS

Contract Labs

- Must work with contract lab to develop custom EDD or
- Do it ourself
- Import into CTS

Compliance Checks

- Must check for compliance more often to ensure that:
 - In-house lab data has been imported
 - Contract lab data has been imported
- Check SNC quarterly after all the data as been imported.
- •LE sends a daily compliance email noting any violations.

Conclusion

Expensive and took a long time to get up and running, however it saves us about 1/3 of an FTE. So, it's a benefit to our program and the SIUs.
